Magna-Grab can be used as a magnetic tag line or tether anchor point on suspended steel loads that don't have ideal attach points. Magna-Grab can be used as magnetic retrieval tool. Retrieve dropped tools, parts, scrap and other objects from hazardous or confined spaces quickly, easily and safely. Magna-Grab can also be used as a holding and positioning hand safety tool.

Do not allow two magnets to come in close proximity to one another or make contact, serious injury and magnet damage can result.






ATTACH/REMOVE HOLD/POSITION


